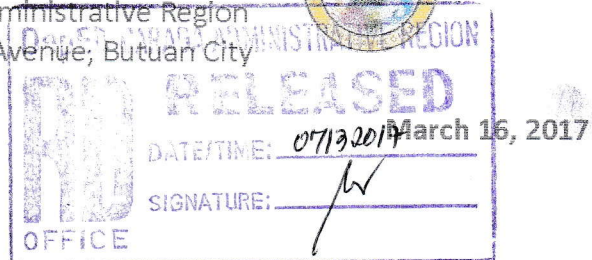

**REGIONAL ORIENTATION AND PILOT TESTING OF MULTI-FACTORED ASSESSMENT TOOL  
(MFAT) FOR THE SPECIAL EDUCATION PROGRAM**

1. Pursuant to DepEd Memorandum DM-CI-2017-00055, dated March 6, 2017; the Department of Education Caraga Regional Office through the Curriculum and Learning Management Division shall conduct a Regional Orientation and Pilot Testing of Multi-Factored Assessment Tool for the Special Education Program on March 22-24 and 27-28, 2017, venue will be announced later.
2. This activity aims to validate the screening tool for further enhancement and as basis for designing appropriate educational interventions and placement.
3. The Regional Team shall randomly select 10 K to 2 learners (4 Kindergarten, 3 Grade 1 and 3 Grade 2) coming from the identified schools of the divisions of Agusan del Norte, Butuan City & Cabadbaran City to take the assessment.
4. The participants are Doris P. Villanueva, Isiah Peligrino and Rema Marie Usi from Agusan del Norte, Angie Villa, Stella Barbosa and Carol Caga from Butuan City and Marietta Bautista, Mary Rose P. Abante, Jeanifer A. Forinas from Cabadbaran City.
5. Board and lodging and travel expenses of the participants during the Regional Orientation and reproduction of materials on MFAT (March 22-23, 2017), and the travel expenses and food allowance during the conduct of Regional Pilot Testing (March 24, 27 and 28, 2017) shall be charged against the Bureau of Learning Delivery-Student Inclusion Division **(BLD-SID-) FY 2017 BEC Funds** subject to the usual accounting and auditing rules and regulations.
6. Check in time shall be on March 22, 2017 at 7:00 o'clock in the morning. The first meal shall be breakfast on March 22, 2017 and the last meal shall be dinner with 2 snacks (am and pm) on March 23, 2017.

7. The Fax Message released dated on March 9, 2017 is totally rejected.
