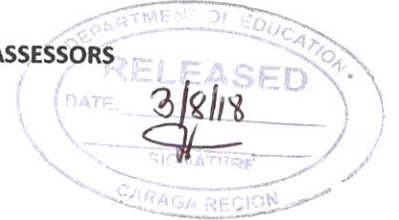

1.
