- 4. The SDOs are given the freedom as to how the allotted number of days be scheduled so that all potential level 3 schools will be visited and validated. Thus, the Division SBM Focal Person is enjoined to coordinate with the Regional SBM

Coordinating Team through the Field Technical Assistance Division (FTAD) for any concerns relative to the validation of schools.

Each SDO is also tasked to identify the Partner Schools considered as best implementer of School-to-School Partnerships which shall also be validated during the visit of the Regional Validators on the date to be specified by the SDO. There shall only be one pair for elementary and one pair for secondary schools per SDO.
