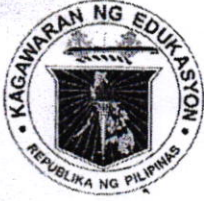
Please be advised of the following prohibited acts pursuant to the said Resolution:

Date	Prohibited Acts
January 13 (Sunday) - June 12, 2019	Transfer or movement of officers and employees in the civil service (Sec. 261 (h), Omnibus Election Code (OEC))
February 12, 2019 (Tuesday) - May 13, 2019 (Monday)	Giving donations or gift in cash or in kind, etc. (Sec. 104, OEC)
March 29, 2019 (Friday) - May 12, 2019 (Sunday)	Appointment or hiring of new employees, creation or filling up of new positions; promotion or giving of salary increases, remuneration or privilege (Sec. 261 (g), OEC)  Construction of public works, delivery of materials for public works and issuance of treasury warrant or similar devises for a future undertaking chargeable against public funds. (Section 261 (w), OEC)  Release, disbursement or expenditures of public funds. (Section 261 (v), OEC).



**SUBJECT:** *Request for exemption on COMELEC Resolution 10429 - Calendar of activities and periods of prohibited acts in connection with 2019 national and local elections*

This has reference to the enclosed **Commission on Elections (COMELEC) Resolution No. 10429** prescribing the calendar of activities and periods of prohibited acts in connection with the May 2019 National and Local Elections. The prohibited acts stipulated in the said Resolution include certain personnel actions such as:

- i. transfer or movement of officers and employees in the civil service,
- ii. appointment or hiring of new employees,
- iii. creation or filling up of new positions,
- iv. promotion or giving of salary increases, remuneration or privilege.

In line with the implementation of the K to 12 program as well as cash-based budgeting, there is an imperative need for the continuous hiring of new public school teachers and non-teaching personnel as well as transfer or movement of DepEd officials and employees.

In view of the above, the undersigned would like to request the facilitation by your office in securing general exemption from COMELEC on these prohibited acts.
