**REGIONAL TRAINING ON THE UNIVERSAL PREVENTION CURRICULA (UPC) ON
SUBSTANCE USE AND ABUSE (BATCH 2)**

To : ALL SCHOOLS DIVISION SUPERINTENDENTS
This Region

1. Substance use is one of the several important social and health issues that society calls on the education sector to address through the curriculum, along with other behavioral prevention areas. Schools have consistently had the most substance prevention programs for children ages 6-14 in urban environments. School counselors are often a part of the prevention programs, frequently taking the role of presenting classroom guidance lessons on topics related to character education and peer pressure. Thus, a Regional Training on the Universal Prevention Curriculum (UPC) on Substance Use (Batch 2) is intended for Guidance Counselors and Guidance Advocates since the first batch of trainees were health personnel, teachers and education supervisors.
2. A 3-Day Regional Training on the Universal Prevention Curriculum on Substance Use (Batch 2) will be conducted on December 27-29, 2018 within Butuan City (exact venue to be announced).
3. In line with this, each Schools Division Office shall send **Guidance Counselors and Guidance Advocates**. Kindly see attached list of pre-identified participants.
