- The Regional Inspectorate Team are required to submit their Regional Inspection Report to the Regional SHS Coordinator in QAD for consolidation purposes three (3) days after the actual ocular inspection.
- 6. In order to facilitate the conduct of ocular inspection by the Regional Inspectorate Team because of the schools geographical locations. The Division SHS Coordinator shall facilitate to gather all School Heads and School SHS Coordinator of DepEd Schools applying for additional program in one venue that is accessible for all the participants to convene. Likewise, the Division SHS Coordinator shall present to the RIT the actual ocular inspection report conducted by the Division Inspectorate Team to the schools.
- The DepEd Schools applying for additional program in the Division of Agusan del Norte, Agusan 7. del Sur, Bislig City, Surigao del Sur, and Siargao Islands are given twenty (20) minutes for their power point presentation in the following areas:
 - a. DepEd School Identification ID;
 - b. Current and projected enrollment for five (5) school years, by grade level;
 - c. Proposed Budgetary requirements for its Personal Services, MOOE, and Capital Outlay for five (5) years;
 - d. Pictures of excess buildings, classrooms, tables, chairs and other resources;
 - e. Inventory of learning resources for the additional program;
 - f. Teacher Profile and their Qualifications (e.g. NC from TESDA for TVL Track, certificate of trainings);
 - g. Number of enrollees in SHS per Track and Strand as determined during the early registration;
 - h. List and types of establishments and industries in the community for possible work immersion;
 - Results of internal assessment or surveys done with the prospective enrollees;
 - MOA executed between the SDS and the partner entity duly notarized;
 - k. Science Laboratory, Computer Laboratory, Internet Facilities, Speech Laboratory (if any), Library, Internet Facilities, Athletic Facilities, and Instructional Classrooms;
 - Ancillary Services (canteen, clinic, guidance office, covered court, amphitheater, SSG office, etc.)
