**Regional Roll-Out of the Multigrade Program in Philippine Education Monitoring and Evaluation System**

1. The Department of Education Caraga Region shall be conducting a Regional Roll-Out of the Multigrade Program in Philippine Education Monitoring and Evaluation System on April 22-24, 2019 at the venue to be announced later.
2. The Objectives of the Roll –Out are to:
  1. develop common understanding on the M & E framework's principle and concepts for the multigrade program among the DepEd personnel;
  2. provide a clear schematic orientation on how to use the developed MPPE M & E system and tools;
  3. discuss how to effectively provide technical assistance to multigrade schools based on M & E findings;
  4. serve as springboard for the formulation of potential guidelines of DepEd policy on MPPE M & E system to be officially adopted by DepEd; and
  5. share their best practices.
3. The participants of the Roll out are the selected PSDSs, School Heads and SDOs MG Coordinator of the 12 divisions in the region. (Note: SDO MG Coordinator shall only be present on the 3<sup>rd</sup> day of the Roll-Out).
4. The School Division Office shall prepare a 3 to 5 minutes power point or video presentation reflecting MG NAT result if any for the last three consecutive years, the number of Multigrade school, number of teachers and the years serving as MG Teacher in their school, issues, concerns and challenges and their best practices while the selected school or district participants shall present their School/ District enrollment, number of Multigrade classes, issues, concerns and challenges and their best practices in enhancing the program.
