

Issuance of Sub-Allotment Release Order (Sub-ARO) on Funding Requirement for the conduct of various activities on ADM Learning Resources Standards

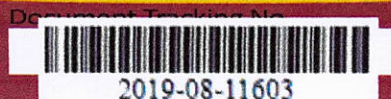
