

The Quality Assurance Division (QAD) shall conduct a **COLLABORATIVE MEETING ON MONITORING & EVALUATION (M&E) AMONG SDO COUNTERPARTS** on November 29, 2019 at the venue to be announced in a later memo. The collaborative meeting highlights on the M & E system that governs RO standards, guidelines, systems and processes that are well-defined and relevant in the context of the region. This shall level-off common understanding of the requirements needed for the issuance and approval of permit as well as the standard processes align on the Quality Objectives and Policies of the Regional Office as ISO 9001:2015 certified.
2. The collaborative meeting shall be attended by Chief SGOD, SEPS M & E, Private School Coordinator, Senior High School Coordinator and Public School Coordinator of the 12 SDOs as well as the staff and personnel of the Quality Assurance Division.
