GUIDANCE FOR SCHOOLS IN THE CONDUCT OF CLASSES FOR SY: 2020-2021

To: Schools Division Superintendents
Asst. Schools Division Superintendents
CID Chiefs
Division Subject Supervisors

1. The guidance for schools in the conduct of classes for School Year (SY) 2020-2021 has been prepared by the regional office as suggestive activities by using different alternative modalities in the teaching-learning process. Since the school opening will not necessarily mean traditional face-to-face learning in classroom, the physical opening will depend on the risk severity grading or classification of a locality, pursuant to guidelines of the Department of Health (DOH), the Inter-Agency Task Force for the Management of Emerging Infectious Diseases in the Philippines (IATF) or the Office of the President (OP).
2. The objectives of this guidance on online learning/emergency remote teaching are to:
 - a. Provide teachers the information in managing online learning;
 - b. Explain the different learning options;
 - c. Identify the type/modality/approach/strategy in learning; and
 - d. Suggest platforms/resources/mechanisms in the delivery of learning.
3. The guidance for teachers in the use of online learning/emergency remote teaching can be downloaded in the link at <https://bit.ly/13modalities> for them to apply in their classes starting August 24, 2020 and will end on April 30, 2021. The teachers can print the said materials using the Maintenance and Other Operating Expenses (MOOE) budget.
