

**INVENTORY OF MENTAL HEALTH AND PSYCHOSOCIAL SUPPORT SERVICES
(MHPSS) MATERIALS**

1. In accordance with DepEd Task Force COVID-19 MEMORANDUM No. 98 entitled "New Schedule and Additional Guidelines on the Conduct of Mental Health and Psychosocial Support Services for the Opening of Classes, School Year 2020-2021", DepEd Caraga shall conduct an inventory to track the printing and availability of MHPSS materials at the Schools Division Offices (SDOs).

Subject: NEW SCHEDULE AND ADDITIONAL GUIDELINES ON THE
CONDUCT OF MENTAL HEALTH AND PSYCHOSOCIAL
SUPPORT SERVICES FOR THE OPENING OF CLASSES,
SCHOOL YEAR 2020-2021

In view of the postponement of the opening of classes from August 24, 2020 to October 5, 2020, the Department of Education (DepEd) issues the new schedule for the implementation of Mental Health and Psychosocial Support Services (MHPSS) for learners. See Enclosure 1 for the details of the MHPSS for learners which will be conducted thru TV broadcast, online and thru self-guided modules.

To maximize the available funds that can be used by field offices for the printing of MHPSS materials, the following additional guidelines shall be considered:

- Regions, Divisions, and Schools shall print the MHPSS materials for those learners who opted to have the modular distance learning modality and have no access to TV;
- For the comics to be provided to elementary learners, the priority to be printed is the comics no. 2; Enclosure 2 includes the cover page and technical specifications of comics no. 2 for reference;
- For the Teacher's Activity Guide for Remote Psychosocial Support through Play for Elementary Learners, it is recommended that only the Learner's Playbook be printed;
