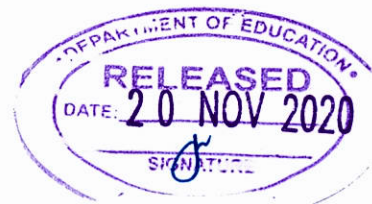

SUBMISSION OF THE DOCUMENTARY REQUIREMENTS FOR LEARNING
 DELIVERY MODALITIES IN THE LEARNING CONTINUITY PLAN
 OF PRIVATE SCHOOLS

1. In DepEd Order No. 017, s. 2020, the compliance of private schools with the minimum requirements stipulated in DepEd Order No. 013, s. 2020 is extended to December 29, 2020. Thus, the Regional Office through the Quality Assurance Division (QAD) issued provisional compliance certificate to schools who complied the minimum program requirements and certificate of compliance to schools with complete documentary requirements.
2. The SDOs through the M & E Section shall require the private schools to submit the lacking documentary requirements especially to those schools issued with provisional compliance certificate.
3. Anent to this, the private schools are required to submit additional requirements of Tuition Fee Schedules approved by the Regional Director and certified true copies of the updated SEC Registration and its Article of Incorporation. The Schools Division Office (SDO) shall validate and certify the documents.
4. Since most of the LGUs are opening its borders, the private schools through the SDOs shall submit the lacking documentary requirements in hardcopy to easily facilitate in the evaluation and validation of the documents.
5. In order to facilitate the submission and evaluation of the required documents on the distance learning delivery modalities of the private schools. The following activities shall takes place in RO and SDO, to wit:
