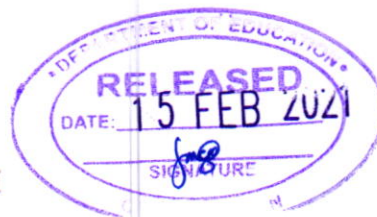

4. All other items stipulated in Regional Memorandum NO. 014 and 055, s. 2021 are still in effect.




