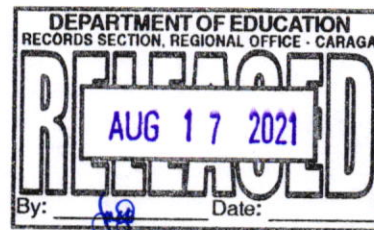

PRESENTATION PORTFOLIO ASSESSMENT FOR ALS ELEMENTARY

Pursuant to DepEd Joint Memorandum DM-OUCI-2021-316 dated August 12 2021, the Alternative Learning System (ALS) Task Force issued the revised with slight modification Re: Presentation Portfolio Assessment for ALS Elementary and Junior High School Program Completers of SY 2020-2021 and Previous Years.

As agreed upon by the 12 Division ALS Coordinators during the 2<sup>nd</sup> CLMD-CID Convergence for Alternative Learning System Program on August 11, 2021, that all SDOs ALS implementers shall conduct the reorientation of Presentation Portfolio Assessment for ALS Elementary and Junior High School Program Completers of SY 2020-2021 as directed by the ALS Task Force during the National Orientation of the abovementioned portfolio assessment last August 12, 2021 headed by Asec. This division undertaking provides all ALS implementers and learners comprehend deeply the adjustment and modification made on the exit assessment of the ALS completers in light of the pandemic in order to have a uniform understanding on the administration of the Presentation Portfolio Assessment across the region.
