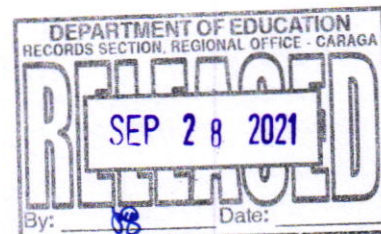

CALL FOR NOMINATIONS TO NEAP – UP COLLEGE OF EDUCATION  
SCHOLARSHIP PROGRAMS BATCH II

1. The National Educators Academy of the Philippines (NEAP) in partnership with the University of the Philippines Diliman (UP Diliman) – College of Education is in the process of gathering nominations for MA scholarships in the following areas:

2. The Division is encouraged to send one (1) nominee for every discipline with the following qualifications:

- a. Filipino citizen
- b. must be 50 years old below;
- c. at least five (5) years of service in the government (DepEd) and has at least two (2) years of very satisfactory (VS) rating;
- d. must hold a permanent appointment at the organization nominating him/her;
- e. must be computer literate and have access to a stable Internet connection to enable them to participate in online interactions;
- f. **has not earned any units in Master's degree nor enrolled in any graduate course;**

- g. must have no pending administrative and/or criminal offense;
- h. Have not been found guilty of any violation involving moral turpitude, corruption, or fraud;
- i. must have a college degree and/or sufficiently demonstrated ability and experience related/relevant to the course he/she is applying for;
- j. must have a good command of the English language (spoken and written);
- k. must have no pending application for retirement at least six months prior to the date of the application for scholarship;
- l. must have no pending nomination for scholarship in another program/course or have already rendered the required service obligation for a scholarship previously enjoyed; and
- m. must be physically and mentally fit as certified by a local government physician.

3. Additional eligibility requirements to the admission into the masteral program as required by the UP College of Education are:

- a. A bachelor's degree from recognized institution of higher learning;
- b. intellectual capacity and aptitude for advanced studies and research;
- c. language proficiency;
- d. taking and passing the Master's Admission Test in Education (MATE); and
- e. satisfaction of additional University requirements such as health clearance and other special admission requirements that may be imposed by the head of the College/Unit through channels.

4. Other documentary requirements set by DepEd as well as that of UP Diliman College of Education are attached to this memo.


5. All documents must be scanned and properly labelled. Applicants must create a folder following this format Surname\_First Name\_Middle Initial (ex. DelacruzJuanA) where all the submitted and properly labelled requirements are uploaded. Upon the completion of the completion of the screening process, an official memo will be released to inform the qualified applicants.
