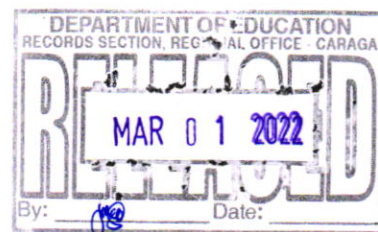

CORRIGENDUM AND ADDENDUM TO REGIONAL MEMORANDUM NO. 0119, S. 2022 RE: OPENING OF THE PROGRESSIVE EXPANSION OF LIMITED FACE-TO-FACE CLASSES

1. The field is hereby informed of the correction and additional provision of Regional Memorandum No. 0119, s. 2022 re: Opening of the Progressive Expansion of Limited Face-to-Face Classes as follows:

a. Correction of entries

- a.1 R. Castillo ES of Bislig City is changed to Labisma NHS to offer Grades 9 & 10
- a.2 Carrascal NHS of the Municipality of Carmen is a wrong entry; thus change to Loyola NHS of the Municipality of Hinatuan to offer Grades 11 & 12. What is correct is Carascal NHS in the Municipality of Carrascal.
- a.3 Victoriana Peling Tagbe NHS of Bayugan City shall offer Grades 7-11
- a.4 Schools with double entries are hereby repealed to mean as the same school

It shall be noted and observed that as soon as there is COVID-19 case in the locality, the school shall automatically halt the implementation of the F2F classes and shall wait for 28 days to lapse before reopening. There is no need for the issuance of Regional Memorandum as this is very clear in the Contingency Plan as highlighted in the School Safety Assessment Tool SSAT).
4. To ensure continuity of the Progressive Expansion of Limited Face-to-Face classes, each SDO is requested to submit list of schools for validation every Tuesday by RFTATs. With this, the Regional Person In-charge will have ample time to encode the updates in the respective google link which is due every Thursday noon.
