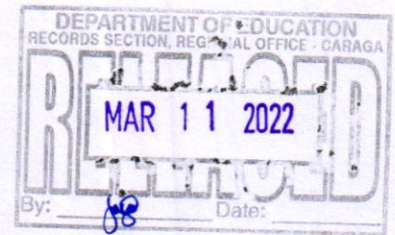

PARTICIPATION IN THE WORKSHOP ON PLANNING AND PROGRAM
IMPLEMENTATION REVIEW (PPIR) ON MADRASAH
EDUCATION PROGRAM (MEP)

1. The Bureau of Learning Delivery- Student Inclusion Division (BLD-SID) will hold a Workshop on Planning and Program Implementation Review (PPIR) on Madrasah Education Program (MEP) for Mindanao Cluster on March 23-25, 2022 to be hosted by Butuan City Division. The specific venue of the event will be announced later in the form of a Regional Advisory.
2. The activity aims to gain invaluable insights on its implementation in the field offices and how it can be improved. Specifically, it aims to:
 - a. present current status, issues, and concerns on MEP implementation;
 - b. share good practices on MEP implementation and reflect on how they contribute to quality learning outcomes; and
 - c. propose plan of actions to ensure effective and sustainable implementation of MEP for 2022.
3. The participants to this activity are the Regional and Division ALIVE Coordinators (RAC and DACs). They are expected to pre-register online at <https://bit.ly/PPIRReg> on or before **March 11, 2022**.
4. Division ALIVE Coordinators are expected to bring laptop, Travel Authority, and COVID-19 Vaccination Card. Moreover, they are also expected to bring the following reports:
 - a. FY 2021 MEP Physical and Financial Accomplishment Report
 - b. FY 2022 Updated Profile of Asatidz by school
 - c. Three-year MEP Enrolment data by school (2019-2022)
5. Participants are advised to take the most economical means of transportation. They are expected to be at the venue a day before the start of the activity. The first meal to be served is **dinner of Day 0 (March 22)** while the last meal will be **afternoon snacks of Day 3 (March 25)**.




