INVITATION TO BID FOR THE Procurement of Supply and Delivery of 2,242 Tablets for Typhoon Odette Affected Schools Division Offices of Dinagat Islands, Siargao, Surigao City and Surigao del Norte

1. The Department of Education-Caraga Region, through the General Appropriations Act 2022 intends to apply the sum of Thirty-Three Million Six Hundred Seven Thousand Five Hundred Eighty Pesos (P33,607,580.00) being the ABC to payments under the contract for the Procurement of Supply and Delivery of 2,242 Tablets for Typhoon Odette Affected Schools Division Offices of Dinagat Islands, Siargao, Surigao City and Surigao del Norte. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Department of Education-Caraga Region now invites bids for the above Procurement Project. Delivery of the Goods is required within 45 Calendar Days. Bidders should have completed, within Five Years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

a. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

4. Prospective Bidders may obtain further information from Department of Education-Caraga Region and inspect the Bidding Documents at the address given below during regular office hours (8:00 AM to 5:00 PM).

5. A complete set of Bidding Documents may be acquired by interested Bidders on August 18, 2022 from the given address below upon accomplishing a bidder's information sheet and payment of a non-refundable fee to the DepEd-Caraga Cashier in the amount of Twenty-Five Thousand Pesos (P25,000.00).

6. The Department of Education-Caraga Region will hold a Pre-Bid Conference on August 25, 2022 at 1:30 PM at DepEd Caraga Regional Office, RPSU Lobby and/or through video conferencing via <https://meet.google.com/hyr-sfneyof> which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 9:00 AM of September 7, 2022. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on September 7, 2022 at 9:00 AM. Bids will be opened in the presence of the bidders'

representatives who choose to attend the activity.

10. Only duly authorized representatives are allowed to purchase bidding documents with Letter of Intent and Special Power of Attorney. Certificate of PhilGEPs Platinum Registration is required.

11. The Department of Education-Caraga Region reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
